A movie is a series of moving images that contain a story and can be watched by people. In addition to entertaining, movies also have the function of providing knowledge and education. There were various themes that can be made into a movie, one of which is a movie about social class and discrimination. This article analyzed the social class and discrimination that occured in a film entitled Saltburn by Emerald Fennel. This article used Max Weber's theory to classify the social classes found in Saltburn, This article also used Theodorson's theory to analyze discrimination in Saltburn. The method used in writing this thesis is the descriptive-qualitative method. The results of the analysis in this article show the existence of social classes, namely the upper class and the middle class. These social classes show differences in lifestyle and position. In addition, there is also discrimination that occured in the movie in the form of verbal discrimination. Based on our analyzed of the film Saltburn, it can be concluded that the existence of social class can affect the way a person socialized and can also clearly show the social status in the film. In addition, the existence of social class can lead to forms of discrimination, one of which is verbal discrimination. (Salsabila, 2021) states where institutionalized power inequality is more widespread and mainstream. In this inequality can be found social classes such as the upper class and the middle class. Based on this, was found that most people feel that they are more powerful, so they cannot accept the presence of others in their family or social class. Social class in society can affect rights and welfare. According to Rahman and Ega in (Welianggen, 2021) Social class can also refer to levels of wealth, influence, and status.

The differences and stratification between individuals or groups in society trigger discrimination. In addition, there are prejudices from one group to another and cause debates as stated by Sabandiah in (Mubarrak & Kumala, 2020). Discrimination is common in social life. Because of differences, humans tend to judge advantages and disadvantages. Examples are discrimination against gender, race, skin color, or physical deficiencies. Discrimination is an act that distinguishes the treatment of one individual or group. Unfair and unbalanced treatment based on differences in race, religion, or social class, as stated by Fulthoni in (Yulinar et al., 2021). Discrimination is also known as unequal treatment of individuals or groups. The term usually describes an action by the dominant, or known as the majority, in relation to the weak, also known as the minority, so that it can be said to be immoral. As stated by Theodorson in (Saludung et al., 2019), discrimination is the unequal treatment of individuals or groups based on something, usually categorical or distinctive attributes, such as race, nationality, religion, or membership in social classes.

There are several studies related to the idea of social class and social discrimination that have been reviewed by previous researchers. The first research conducted by Muhammadaliunm, 2023. This journal explains about social class and discrimination that occurs in the film "Upside Down" by Juan Solanas. This journal also explains how the impact of the problems on the main character in the movie. This journal using Karl Marx theory in (Ali & Sunra, 2023) It is concluded that in this movie the social class is divided into two, namely the bourgeoisie and the proletariat. This research is a descriptive qualitative method that aims to analyze the conflict of social problems experienced by Adam.

The second research was conducted by Apriliani, 2023. This research uses qualitative methods and in analyzing the data the researcher uses marxist theory in (Apriliani & Efendi, 2010). The findings of this research are divided into two classes of society. The first is the upper class as the bourgeoisie and the second is the lower class as the proletariat. Each reveals about the social life, lifestyle, and behavior of the bourgeoisie. In addition, researchers also found an impact on people's lives in the movie Snowpiercer.

The third research was conducted by Dianiya, 2020. This study researchers explained how class differences exist in two families in the film Parasite by Bong Joon-Ho. This journal using Karl Marx theory in (Anjani & Junaedi, 2022) In the analysis stage, researchers used Roland Barthes' semiotic analysis, namely signs in the form of words, images, sounds, movements and objects. It is analyzed based on three things, namely the decomposition of data based on meaning, connotation, denotation and myth contained in the parasite film scene. In this study, researchers used a mixed paradigm method or interpretive critical approach that analyzes the structures of great power that guide everyday life.

The fourth research by Anita Anggraeni Dewi, 2022. The main study in this research is to explain discrimination in the Zootopia film and the characters in the film who present discrimination in the Zootopia film. In this study, researchers used a descriptive qualitative method. The researcher wanted to analyze the discrimination experienced by the main character in the film Zootopia. This journal using Blank theory in (Dewi et al., 2022) Researchers found two forms of discrimination in Zootopia, namely verbal and non-verbal discrimination.

The last research entitled Discrimination Analysis Of The Main Character In Movie Crazy Rich Asians. This journal using U.S. Equal Employment Opportunity Commission in (Jimmi & Mawadah, 2021). The purpose of this study is to explain the types of discrimination addressed by the main character in the movie Crazy Rich Asians. From the results of the research analysis, it was found that harassment, racial discrimination, and religious discrimination were experienced by the main character. Not only that, researchers found four types of impacts experienced after experiencing discrimination, namely marginalization, powerlessness, low self-identity and criminality. In this study, researchers used a qualitative descriptive method.

Based on the review of the five journals above, researchers found similarities between the journals that have been reviewed and the research to be studied, namely both examining social class and discrimination that generally occurs in society due to differences or classifications in society. Therefore, this study aims to examine social class and discrimination in the movie Saltburn. With this study, researchers hope that people in Indonesia will no longer discriminate despite differences in social class and can understand the factors that cause it so that they can avoid it. In this study, researchers used a different theory from previous studies. In this study, researchers used Max Weber's theory and researchers used a different object, namely the movie Saltburn. The researcher also analyzes the causes of social class and discrimination in the main character. With this analysis, the researcher aims to describe and describe the social class and discrimination in the main character in the movie Saltburn.

METHODOLOGY

The varieties of social class and discrimination in movie Saltburn are examined in this study using a qualitative descriptive technique. The author decided to employ this technique to gain more knowledge. According to Endraswara in (Susel Piatun, Vera Magria, 2020) qualitative descriptive method is a method used in research that describes research data through words.

Data is gathered using three different methods: watching the movie, audiovisual and taking notes. To finish the analysis, the authors followed a set of guidelines. First, Saltburn movie was chosen for analysis by the researcher. After that, the researcher viewed the movie and noted the types of social class and discrimination that it discussed. Subsequently, the author examines the many forms of social class based Max Weber Theory and examines the many forms of discrimination based Newman theory. Finally, the researcher drew a conclusion from the study. Their life behavior is very structured and not lacking. They have many bodyguards and servants who serve their family. Their luxurious living quarters and large mansion show their social status in the society, which is the upper class. Not only the upper class but there is also a middle class described by Oliver's character. The middle class is depicted with sufficient social conditions and status, which can be said that this middle class is not on the threshold of the lower class and is also not equal to the upper class. A stable life and sufficient property ownership do not make them satisfied and still want to be equal to the upper class, reflected in Oliver's behavior, which makes every effort to enter the world of the upper class by utilizing the scholarship he has at Oxford, and hanging out and using Felix who is an upper class person by manipulating, playing victim and deceiving Felix and his family. This is done to be able to be equal to have the same power and position. As stated by Max Weber in (Cinthya, 2020) Social class is identified based on status and power.

A discrimination category in this research is seen from verbal type. The main character in the movie Saltburn will be the subject of analysis. Unag is a surefire way for rich or upper-class people to deal with things. They think that giving someone a large amount of money can solve all problems. In the general public, there are many similar cases where people who are bribed or given money often accept it for free and sometimes they even ask for more than the amount given so that they keep quiet and obey the wishes of the giver. This is why many rich people think that money is everything.

In this case, a person's background can be a determinant in social class which impacts their treatment in society. Labeling in social class arises easily because of the differences between social classes based on income, status and power. Max Weber in (Aji, 2015). Based on the results of the above research, it can be concluded that what the main character experienced in the movie Saltburn is very representative of the state of social class and the discrimination that can occur in it.
